
Sir,

In continuation of this Ministry's Sanction Order of even number **dated 26.03.2017**, I am directed to convey the approval of the President of India to sanction additional 120 Nos. of trainees under the Nai Manzil Project to **Thredz information Technology Private Ltd., 203, 2<sup>nd</sup> Floor, Reliance Mansions, Lower Tank Bund, Hyderabad – 500029 and Sri Chakra Paints Pvt. Ltd., Navi Mumbai for Telanagana**. The total number of trainees has been enhanced to 970 Nos. from 850 Nos. with this additional allocation. Consequently, the cost of the Project has also been enhanced to Rs. 5,48,05,000/- from Rs. 4,80,25,000/-. This cost ceiling is subject to common norms of Ministry of Skill Development & Entrepreneurship for skill component applicable from time to time.

I am also directed to convey the sanction of the President of India for release of Rs. 20,34,000/- ( Rupees twenty lakh and thirty four thousand only) (making total release to Rs. 1,64,41,500/-) for 970 trainees as 1<sup>st</sup> installment (30%) of Grants-in-aid to **Thredz information Technology Private Ltd., 203, 2<sup>nd</sup> Floor, Reliance Mansions, Lower Tank Bund, Hyderabad – 500029 and Sri Chakra Paints Pvt. Ltd., Navi Mumbai** during 2016-17. No Utilization Certificate is due for rendition in respect of schemes/programmes/project of the Ministry/Department.

3. The other terms and conditions of the Sanction Order of even no. dated **25.03.2017** are also applicable to this allocation and release of Grants-in-aid to P.I.A.

The Drawing and Disbursing Officer (DDO) of this Ministry is hereby authorized to draw an amount of Rs. 20,34,000/- ( Rupees twenty lakh and thirty four thousand only) as the payment of first installment to **Thredz information Technology Private Ltd., 203, 2<sup>nd</sup> Floor, Reliance Mansions, Lower Tank Bund, Hyderabad – 500029 and Sri Chakra Paints Pvt.
