The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes and Minorities) -Other Grants (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 – Grant for creation of capital assets for the year 2017-18.

A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified 4. that no UC is pending for this project.

Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year.
