Sir,

I am directed to say that your proposal for release of grant-in-aid under 'Free coaching and allied scheme for the candidates belonging to minority communities", has been considered in the Selection Committee meeting held on 14.11.2011. It is informed that your institute has been selected for imparting coaching/training to **List enclosed** candidates for **List enclosed**.

2. You are required to issue advertisements in local newspapers inviting applications from students/candidates belonging to minority communities for the approved coaching/training courses and select candidates who are eligible as per provisions of the scheme. The list of selected students may be furnished to this Ministry in the prescribed performa alongwith the break-up of local and outstation students/candidates <u>immediately</u>. The same should also be uploaded on the website of the coaching institute. Website address may be furnished to the Ministry along with the list of candidates selected for coaching.

3. The selection of students may be made centre-wise. Those institutes who preferred to impart coaching in more than one centre may be required to submit the infrastructure details in the prescribed format (copy enclosed) of the actual coaching centre alongwith the list of students. Efforts may be made to cover maximum districts of the State invariably the MCDs.

4. As per provisions of para 7 of the modified scheme, the coaching institute are required to have a website, containing details of the names of the student coached/trained during the last three years, their addresses, the course for which coaching/training was imparted, the roll no. of the test/examination/etc. for which they appeared, their result and outcome or placement status and the year-wise success rate along with information on faculty members, their qualification and the infrastructure of the institute. In addition to these, the grantee institutes shall reflect the sanctioned stipend amount paid to the students/ candidates concerned against their names.

5. Further, you are also required to furnish PAN/TAN/TIN No. of your institute and Bank authorization letter in the prescribed proforma containing bank details duly verified by the bank manager on their letter head and seal alongwith IFSC code of the bank branch for sending payment directly into your bank account. Those institutes who have not submitted 'Bond' alongwith their proposal require to submit the same.

6. From this year 2011-12, this Ministry is going to launch online monitoring system enabled with GPS mobile handset. For which each institute has to procure a GPS mobile set from its own resources. The requisite software for uploading of photographs of classrooms will be provided by NIC. An orientation programme will be convened in Delhi for familiarization of the system before the actual commencement of coaching classes. The date of orientation programme will be intimated subsequently. The institute may therefore be fully prepared for the web-based monitoring system.

7. It is informed that funds would be released for the coaching programme only on receipt of list of candidates selected by the institute for the above coaching/training courses programmes and the website address of the coaching institute having all the relevant details.

8. The list of selected students in the prescribed format should reach to this Ministry **within the shortest time possible and not beyond a period of one and a half months i.e. 45 days** from the date of issue of this letter.

WHEREAS the obligors has sent a request proposal to Government, through the Union Ministry of _______for Gants of Rs.______Vide his Letter number_____Dated_____; the obligors has agreed to execute this bond in advance, in favor of Union Ministry of _______for entire amount of Rs.______as requested in the proposal sent to the Government. The obligor is willing to accept the proposed amount or any other amount approved/sanctioned by the Government. The obligor will be bond upto this amount or by the actual amount approved/sanctioned by the Government, whichever is less. The obligor is also willing to accept all terms and conditions mentioned in the "Letter of Sanction" to be issued by the Government.

4.
