**FUNCTIONS OF THE SAMITI**

2. The functions of the Samiti are to render advice with regard to the implementation of the provisions relating to Official Language Hindi contained in the Constitution, Official Languages Act and Rules, and Policy decisions of the Kendriya Hindi Samiti and instructions issued by the Department of Official Language relating to Official Language Hindi and also in regard to the Progressive use of Hindi in the Ministry of Minority Affairs.

### TENURE

3. The tenure of the members of the Samiti shall ordinarily be three years from the date of its constitution provided that:
- A. A member, who is Member of Parliament, ceases to be a member of the Samiti as soon as he/she ceases to be a Member of Parliament.
  - B. Ex-officio Member of the Samiti shall continue as members as long as they hold the office by virtue of which they are members of Samiti.
  - C. If a vacancy arises in the Samiti due to resignation, death etc. of a member, the member nominated on the vacancy shall hold office for the remaining period of the Samiti.
  - D. If a person is nominated as a member of the Samiti in the middle of its tenure, he/she shall be member of the Samiti for the remaining period.
4. The Headquarters of the Samiti shall be at New Delhi, but if considered necessary, it may hold its meetings at any other places also.


### Traveling Allowances and other Allowances

5. Traveling allowances and Daily Allowances would be paid to the non-official members of the Samiti for participating the meetings as per the instructions contained in the Deptt. of official Language's O.M. No. 11/20034/4/86-OL (A-2) dated 22.1.1987 and as per the rates prescribed by Govt. of India from time to time.

### ORDER

Order that a copy of this resolution be communicated to all Members of the Samiti, all State Governments and Union Territory Administrations, Prime Minister's Office, Cabinet Secretariat President's Secretariat, Vice-President's Secretariat Committee of Parliament on Official Language, Comptroller and Auditor General, Accountant General, Central Revenues, Lok Sabha Secretariat, Rajya Sabha Secretariat and all the Ministries and Department of the Government of India.

Ordered also that the Resolution be published in the Gazette of the India for general information.
