Subject: Release of 1st installment (70%) of non-recurring Grant-in-Aid for the year 2013-14 to 'Islamia Education & Charitable Society, Near Indira Park Deoband, Distt. Saharanpur, Uttar Pradesh -247554' for organizing Leadership Development training programme at Saharanpur District (Uttar Pradesh) under the "Scheme For Leadership Development of Minority Women".

Sir,

I am directed to convey the sanction of the President of India for an amount of Rs. 10,21,500/- (Rupees Ten lakh twenty one thousand and five hundred Only), towards the cost for organizing Leadership Development training for Minority Women for 125 (One Hundred And Twenty Five Only) Non Residential training and 75 (Seventy five only) Residential for selected trainees at Saharanpur District (Uttar Pradesh) and release of Rs.2,50,425/- (Rupees Two Lakh Fifty Thousand Four Hundred And Twenty Five Only) for Non -Residential and Rs. 4,64,625/- (Four lakh Sixty four thousand six hundred and twenty five only) for Residential as first installment(70%) during the year 2013-14, to 'Islamia Education & Charitable Society, Near Indira Park Deoband, Distt. Saharanpur, Uttar Pradesh -247554' as per details at Annexure - I. The above sanction is subject to fulfillment of following terms and conditions as given in para 2(i-xii) and the Guidelines prescribed under the Scheme:

2 (i) Grant-in-aid has been given to the above mentioned organizations on the basis of the recommendation of Government of Uttar Pradesh. It is incumbent on the part of Government of Uttar Pradesh to ensure that the organization recommended by them utilize the fund for the purpose it has been sanctioned.

(ii) The Organization will not obtain grant for the same purpose or activity from any other Ministry or Department of Government of India or State Government and or any other body.

(iii) The Organization will not divert grant-in-aid and entrust the execution of the project for

grant should be utilized for any new/other scheme for which prior approval of Government has not been obtained.

(iv) The organization will submit the Progress Report and Expenditure Statement as soon as the training is complete. It should be item wise. Format may be seen on website of the Ministry of Minority Affairs at <http://www.minorityaffairs.gov.in/>.

(v) The Organization will maintain subsidiary accounts of the Government grant and furnish the audited statement of accounts with utilization certificate in GFR 19 (A) at the end of financial year 2012-13 to the Government.

(vi) The accounts of the Organization shall be open to inspection by the sanctioning and recommending authority and audit, both by the Comptroller and Auditor General of India and Internal Audit Wing of Officer of Chief Controller of Accounts of this Ministry, whenever the Organization is called upon to do so.

(vii) The assets acquired wholly or substantially out of Government grant should not be disposed of without prior sanction of the President, encumbered or used for purpose other than those for which grant has been sanctioned. The organization is required to maintain a Register of such assets and send an annual statement in the prescribed proforma to this Ministry at the end of the financial year:

(viii) If the Government is not satisfied with the progress of the project or considers that the conditions of sanction are being violated, it reserves the right to terminate the grant-in-aid and/or to blacklist the organization from future grant or any other financial assistance from the Government, apart from taking appropriate civil and criminal legal action.

(ix) It is further certified that grant-in-aid to the grantee is sanctioned in accordance with pattern of financial assistance approved and is in conformity with guidelines of the Scheme.

(x) The Grant-in-Aid is further subject, to the conditions laid down in General Financial Rules as amended from time to time.

(xi) The Grants-in-Aid is further subject, to the conditions to the provisions including Financial norms as laid down in the "Scheme for the Leadership development of Minorities Women" and further instructions/directions from the Government of India from time to time.


(xii) As per para 20(e) of the "Scheme for Leadership Development of Minority Women", the organization shall utilize the financial assistance for the specified purposes only. The organization shall give an undertaking that in the event of acting in contravention of this condition, it will refund the amount received from the Government with 18% annual penal interest and any other action, as deemed necessary by Government.

3. Certified that there is no unspent balance available with the organization.

4. Certified that this sanction has been noted at Sl. No. 36 in the Register of Grants.


6. The **Drawing & Disbursing** Officer of this Ministry will prepare the bill for an amount of Rs. Rs.7,15,050/- (Rupees Seven Lakh fifteen Thousand and Fifty Only),1st installment for the year 2013-14, in favour of 'Islamia Education & Charitable Society, Near Indira Park Deoband, Distt. Saharanpur , Uttar Pradesh -247554' The amount may be transferred electronically through RTGS to the Organization's Bank, (Corporation Bank) Account No. 0786010001004573, MICR Code - 247017002, IFSC/RTGS Code - CORP0000786.

8. The Grant-in-Aid is sanctioned under the additional power delegated to this Ministry vide Ministry of Finance' Officer Memorandum No. F10 (a) E (Coord.) 62 dt. 1st June 1962. The sanction letter is issued with the concurrence of JS & FA vide Dy. No. 155, dated 10.06.2013.
