Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Blocks (MCBs) to Government of **West Bengal for Medinipur District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 17.08.2015. I am directed to convey the sanction of the President for release of total amount of **Rs.1,33,53,000/- (Rupees One Crore Thirty Three lakh Fifty Three Thousand only)** as 2nd instalment for the year 2017-18 to the Govt. of West Bengal for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for Medinipur District as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of West Bengal through CAS, Reserve Bank of India, Nagpur.

2. The State Govt. should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency alongwith Central share.
3. Grant-in-aid under, Demand No.66 Ministry of Minority Affairs Major Head – "3601" Grant-in-aid to State Government,06-Grants for Centrally Sponsored Plan Scheme (Sub Major Head), 101-General-(Welfare of Schedule Tribes, other Backward Classes and Minorities) – other grants, 49- Multi-sectoral Development Programme for minorities, 49.00.35-Grant for creation of capital assets for the year 2017-18.
4. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
5. The State Government should ensure that a board containing information as per Template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
6. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.


