Subject: Publishing advertisement by States/UTs to implement Meritcum Means based Scholarship Scheme for the year 2013-14.

Sir.

I am directed to say that the Merit-cum means based Scholarship Scheme is a Centrally Sponsored Scheme launched in the year 2007. From 2012-13, 60,000 fresh scholarships are proposed to be awarded every year in addition to the renewals to students among the notified minority communities for pursuing professional and technical courses, at under-graduate and post-graduate levels, in institutions recognized by the appropriate authority.

- 2. Under Merit-cum Means based Scholarship Scheme, there is no financial target. However, physical target in respect of 60,000 Fresh Scholarships every year has been fixed in accordance with State-wise population of minority communities. The State/UT-wise breakup of 60,000 Fresh Scholarships has been uploaded on the website of this Ministry. A copy of the same is also enclosed for ready reference.
- 3. States/UTs are already aware of the fact that Online Scholarship Management System (OSMS) has been introduced from the year 2011-12. The site can be accessed through the URL www.momascholarship.gov.in. A link to the site is also made available in the website of Ministry i.e. www.minorityaffairs.gov.in.
- 4. Attention is drawn to para-vii of terms and conditions which states, "The State Department will advertise the Scheme every year latest by 31st March and receive the application through the concerned Institutions."
- 5. The State Government/UT Administration is accordingly requested to publish advertisement inviting applications for the year 2013-14 by 31st March, 2013 and adhere to the following time line with regard to various activities related to submission of proposals to this Ministry:-

In order to provide flexibility in the activity timeline under Merit-cum Means based Scholarship Scheme, according to the academic year of the particular States/UTs, it is requested that alternate timeline for Fresh and Renewal applications under Merit-cum Means based Scholarship Scheme for your State/UT may be indicated latest by 20th March, 2013. If no alternative timeline is received by 20th March, 2013, it will be presumed that the States/UTs are in agreement with timelines proposed by this Ministry. In no case the last date be later the 31st October, 2013 for Fresh Scholarships and 5th February, 2014 for Renewal Scholarship. Therefore, States/UT can have maneuverability in Sl.No.1 to 5 of timeline for fresh and Sl.no. 1 to 4 of timeline for Renewal.

- 7. With regard to the renewal proposals, the States/UTs can submit proposals in small batches of atleast 10 to 15 applications, as and when scrutiny is complete in all respect as no merit list is required to be generated in case of renewals. This will facilitate the Ministry to incur the desired expenditure and in meeting 2/3rd expenditure by December of Financial Year 2013-14.
- 8. The State Government/UT Administration is also requested to bring to notice the Online System and provide detail information to students in the advertisement. In the advertisement, the State/UT Department may also invite attention of the students to the Frequently Asked Question (FAQs) available on the homepage of the website for filling up of online application. The timeline of activities desirable for students may also be advertised after due approval of Government of India. Applicants may also be advised to take print-out of the duly filled-in application forms, through OSMS, and submit the same alongwith all supporting documents through their respective institutes to the State/UT Department. It may be highlighted that without receipt of hard copy in the State/UT Department, the application is liable to be rejected. Aadhaar number is mandatory this time.
- 9. The State/UT should fulfill all terms and conditions contained in the Scheme at the time of submitting the proposals. It may also be ensured that proposals are submitted alongwith utilization certificate in GFR-19 A.
- 10. The State Governments/UT Administrations are also advised to indicate to this Ministry, the status of disbursement of scholarships released in the year 2012-13. The State Governments/UT Administrations must upload on their respective websites, the detailed list of students who have been given scholarship in the previous year so that the same could be hyperlinked with the website of this Ministry. Failure to place the list of beneficiaries for the year 2012-13 may result in non-consideration of proposals in the Financial Year 2013-14.
