
**Subject: Proposal for advance grant of administrative expenses to the State Government of Gujarat during the financial year 2014-15.**

I am directed to convey the sanction of the President for release of recurring grant-in-aid of ₹ **7,06,350/- (Rupees Seven Lakh Six Thousand Three Hundred Fifty Only)** as 100% Central Share to the Government of Gujarat, for implementation of the Scheme of Post-matric scholarship for students belonging to the minority communities, for the year 2014-15 for the purpose of Administrative Expenses.

2. The recurring grant may be released to the Government of Gujarat through CAS, Reserve Bank of India, Nagpur.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months of the closure of this financial year. It is also to be certified by the grantee that no utilization certificate is pending in respect of previous grant/grants.
