**Indira Awas Yojana**

- (a) The State Government should ensure that the IAY houses would be distributed in villages having more than 30% of minority population and BPL families selected from the approved waiting list, even if they belonged to communities other than the minority communities, strictly in order of their ranking in the list as per the IAY guidelines.
- (b) State share would be provided.
- (c) The list of the villages along with the number of houses to be constructed would be furnished by the State Government.
- (d) To prevent duplication, the Government of Uttar Pradesh should ensure that the units funded under MsDP were reflected in the State Action Plan of the scheme and inform the Central Ministry concerned.

**Construction of Anganwadi Centres:**

- (a) The State Government should ensure that the centres would be located in villages which have the highest concentration of minority population and spread across all the blocks.
- (b) The State Government assured to provide a list of villages where these centres would be constructed.
