

Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Block (MCB) to Government of **Uttar Pradesh**.

Sir,

In continuation to this Ministry's sanction letter of even number dated 21.04.2015, I am directed to convey the sanction of the President for release of an amount of **Rs.5, 53, 93, 200 /-** (**Rupees Five crore Fifty Three lakh Ninety Three thousand Two hundred only**) as 2<sup>nd</sup> instalment (50% of total central share) to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration District" for 300 schools in Minority Concentration Blocks/Towns as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of UP through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.60, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 – Grant for creation of capital assets for the year 2016-17.
3. The State government should ensure that proportionate share of 50% of State share for the projects mentioned at annexure –I is released to the implementing agency along with Central share.
4. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for this project.
5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report,
