TERMS AND CONDITIONS:


1. The bidder should be a HP authorized reseller. Certificate to this effect from HP Corporation needs to be attached along with the bid.

5. The tender should be signed in each page by the representative of the party.

9. The Printer is to be supplied within a period of 2 weeks from the date of issue of Purchase Order (PO) by the Ministry.
10. In the event of defective supply of sputious material leading to rejection of material, the supplier will replace the material with genuine one without extra cost.
11. Payment will be released after successful delivery of the product.
12. The Ministry does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.
